Note: Access Transportation Professionals Advisory Committee meetings are held pursuant to the Ralph M. Brown Act [Cal. Gov. Code §54950] and are open to the public. The public may view and obtain all written information supporting this agenda provided to the committee both initially and supplementary prior to the meeting at the agency's offices located at 3449 Santa Anita Avenue 3rd Floor, El Monte, California and on its website at http://accessla.org. Documents, including Power Point handouts distributed to the committee by staff or committee members at the meeting will simultaneously be made available to the public. Three opportunities are available for the public to address the committee during a committee meeting: (1) before a specific agenized item is debated and voted upon regarding that item and (2) general public comment. The exercise of the right to address the committee is subject to restriction as to time and appropriate decorum. All persons wishing to make public comment must fill out a yellow Public Comment Form and submit it to Access staff. Public comment is generally limited to three (3) minutes per speaker and the total time available for public comment may be limited at the discretion of the Chair. Persons whose speech is impaired such that they are unable to address the committee at a normal rate of speed may request the accommodation of a limited amount of additional time from the Chair but only by checking the appropriate box on the Public Comment Form. Granting such an accommodation is in the discretion of the Chair. The committee will not and cannot respond during the meeting to matters raised under general public comment. Pursuant to provisions of the Brown Act governing these proceedings, no discussion or action may be taken on these matters unless they are listed on the agenda, or unless certain emergency or special circumstances exist. However, the committee may direct staff to investigate and/or schedule certain matters for consideration at a future committee meeting and the staff will respond to all public comment in writing prior to the next meeting.

## CALL TO ORDER

TPAC Chair Diane Amaya called the meeting to order at 9:33 am.

#### APPROVE MARCH 9, 2023 MEETING MINUTES

## **GENERAL PUBLIC COMMENT**

Fernando Roldan made a public comment by stating that he is a member of California Communities Actively Living Independently Free. He knows there are some issues with the Next Gen program, especially in the Porter Ranch area. He invited them to join his meeting that afternoon at 1pm. He also added that by Metro removing certain routes from their service, it will hurt the riders and he believes it is against the ADA.

#### **EXECUTIVE DIRECTOR'S REPORT**

Executive Director, Andre Colaiace, announced that the Federal Transit Administration reported that Access Services had successfully helped Redondo Beach in their triennial review in terms of completing the ADA paratransit portion of the triennial. They are continuing to work on our TNC Pilot Program and making progress. Global has had extensive discussions with Uber, and we believe that another contractor is also interested in pursuing that. They are targeting to launch in July of this year, although there are a lot of moving parts here. Randy Johnson and he were recently in Washington, D.C. They met with the FTA Office of Civil Rights to update them on Access Services and some of the things that they did during the pandemic. They also met with a few other legislative offices, congressional offices about an earmark request for the paratransit operations and maintenance facility in the city of Lancaster, California, which would be Access's first wholly owned paratransit operations and maintenance facility. On the House side, Congressman Mike Garcia, who represents the north county and Lancaster specifically has recommended to the Appropriations Committee for a \$3 million earmark. On the Senate side, Senator Alex Padilla has recommended to his Appropriations committee that they receive \$7 million. It's very good news that they have been afforded to the Appropriations committees on both sides of Congress.

### FY 2024 DRAFT BUDGET

Deputy Executive Director Hector Rodriguez gave an update on the consideration for the '23-'24 budget. As outlined in the slides, they asked HDR, which is their econometric firm, to provide them with a forecast for the upcoming fiscal year. They are provided with actuals through December and then they must project through the last six months of the current fiscal year as well as the upcoming fiscal year. They update the '23 forecast as well as forecast the next coming fiscal year, which is for FY '24.

## TRAVEL MODE SURVEY RESULTS

Eric Haack presented this item along with Catherine Veschi, project manager at Great Blue Research. They presented the results of a recent customer survey that focused on different transportation services that Access-eligible customers use to get around Los Angeles. Access has conducted a number of customer surveys in the past and they have used the results to determine overall customer satisfaction with Access's service or specific aspects of the services that Access provides. For instance, satisfaction with something like, beyond the curb service or focus on experiences that some customers have experience with, such as traveling with a mobility device or traveling with a service

animal. The survey being discussed today was a more focused survey asking about different transportation services that a customer may use to get around Los Angeles.

## **OPERATIONS REPORT**

Project Administrator, Faustino Salvador, presented the performance statistics and KPIs. Some highlights he shared were how Access staff assisted with the pickups and drop-offs at the Abilities Expo from March 10 to March 12. Access also shared a booth with L.A. Metro to speak to participate at the expo along with answering questions as well. Access assisted with the Walk MS (Muscular Sclerosis) event on April 16th. Stacy Nonoguchi, who is a recreation therapist at the Maryland center and UCLA thanked Access for their assistance for the event. Ms. Nonoguchi commended CTI supervisor Eugene Estrada for being terrific as the event went well. Access staff attended the South Los Angeles Regional Center AAC (Accessibility Advisory Committee) meeting on April 24. He and Mobility Management administrator, Steve Wrenn attended the meeting. They were able to answer all questions from SLARC staff and members. SLARC thanked Access for attending their first in-person AAC meeting. On May 1, 2023 they marked the one-year anniversary of First Transit providing service in the Antelope Valley. Lastly, Access is monitoring the OCTA strike and the potential impact on Access riders. Effective March 31, 2023, masks are no longer required but are strongly recommended for riders and drivers on board Access vehicles. This change in policy is in keeping with L.A. County and with the COVID-19 emergency declaration but they encourage masks for safety.
