Public comment is generally limited to three (3) minutes per speaker and the total time available for public comment may be limited at the discretion of the Chair. Persons whose speech is impaired such that they are unable to address the committee at a normal rate of speed may request the accommodation of a limited amount of additional time from the Chair but only by checking the appropriate box on the Public Comment Form. Granting such an accommodation is in the discretion of the Chair. The committee will not and cannot respond during the meeting to matters raised under general public comment. Pursuant to provisions of the Brown Act governing these proceedings, no discussion or action may be taken on these matters unless they are listed on the agenda, or unless certain emergency or special circumstances exist. However, the committee may direct staff to investigate and/or schedule certain matters for consideration at a future committee meeting and the staff will respond to all public comment in writing prior to the next meeting.

ITEM 2 TRANSPORTATION PROFESSIONALS ADVISORY COMMITTEE MEETING MINUTES FOR THURSDAY MAY 9, 2024

CALL TO ORDER

TPAC Chair Fayma Ishaq called the meeting to order at 9:37 a.m.

APPROVE MARCH 14, 2024 MEETING MINUTES

Motion: Fayma Ishaq entertained a motion to approve the March 14, 2024 minutes.

The approval of the minutes was postponed until the July meeting because it had not been posted within the required 72-hour limit.

GENERAL PUBLIC COMMENT

None

EXECUTIVE DIRECTOR'S REPORT

Executive Director, Andre Colaiace stated that the Board approved the zero-emission bus rollout plan submitted to the California Air Resources Board as required by the Innovative Clean Transit regulation. CARB staff has reviewed the rollout plan and concluded that it met the requirements. Staff are continuously looking for accessible paratransit vehicles that are both electric and hydrogen. Their electric vehicles are undergoing federal safety testing in Altoona, Pennsylvania, and they are working on a hydrogen vehicle concept as well. He stated that currently there were no vehicles that

meet the ZEB requirements that will work for Access, but they are working on that. The Federal Access Board, not to be confused with Access Services, is an independent agency that promotes equality for people with disabilities through leadership and accessible design, and the development of accessible guidelines and standards. From April 15 to April 19, the Federal Access Board held its quarterly meeting in Los Angeles to understand the state of accessibility in the city. On Thursday, April 18th, they spent the whole day looking at accessibility in the city of Los Angeles as it prepares for the Olympic Games, and he participated on the panel and discussed transportation accessibility and facilities. He discussed the role that Access Services plays in making Los Angeles accessible, and how new infrastructure like bike lanes need to consider paratransit in their design. He mentioned that current Federal Buy America laws are making it increasingly difficult to develop accessible paratransit vehicles. They are also requesting \$20 million for the Antelope Valley paratransit operations and maintenance facility in Lancaster through the Federal Buses and Bus Facilities Program. This request is in addition to our submission to the Federal RAISE Grant for the same amount of money.

FY '25 DRAFT BUDGET

Hector Rodriguez presented the proposed FY 2025 budget. He went through the forecasted percentages on the proposed budget. He explained that the current trend is increasing demand, and it will continue to rise through the end of the year. In terms of capital construction for the Antelope Valley, they have budgeted about \$8 million because they expect some costs to come in FY25 but most of the construction costs will come in FY26. By the end of the month, they'll try to finalize the budget and then present the final draft budget to the Board in May 2024. They won't finalize everything until they take the final budget for approval to the Board in June 2024.

PUBLIC COMMENTS

Yael Hagen made a public comment by stating that people with disabilities and seniors who were able to use a mix of fixed route and paratransit are using fixed route less. Primarily for safety reasons and that does make an impact. She stated there were many bus stops that were still not ADA-compliant, and that also makes a difference. There are not a lot of viable transportation options for people with disabilities, and Access is the largest of them. Quality of service should be good because when they have an obligation to provide something to the public, it should be quality.

OPERATIONS REPORT

Garrett Rodriguez presented the statistics for the operations report. In early April, the Antelope Valley region hired a new general manager, Victor Garate. Victor has worked in the Southern region for Access in the past, and most recently as the Antelope Valley operations manager. Access attended the Los Angeles Disabilities and Aging Collaborative on April 11. Access was able to connect with a diverse group of professionals, advocates, and individuals with lived experience. Project administrator, Faustino Salvador, and mobility management administrator, Steve Wrenn, were in attendance representing Access. Additionally, their senior road safety inspector has been working with the City of Long Beach and Long Beach Transit to implement, adding a total of three stand signs at the Aquarium of the Pacific. Lastly, in terms of vehicle acquisition, 121 ProMasters have been delivered to the contractors as of May 3rd. This concludes the order of 58 ProMasters. The order of 101 vehicles is making progress with approximately six deliveries per week.

APPROVE JANUARY 11, 2024 MEETING MINUTES

GENERAL PUBLIC COMMENT

None

EXECUTIVE DIRECTOR'S REPORT

Executive Director, Andre Colaiace announced he went to Washington DC with Randy Johnson. For the first time in 10 years, Congress was accepting proposals for earmarks. They are projects that individual congressional offices can propose for funding through appropriations bills. Last year Access put in a request for \$3 million for the construction of our Antelope Valley Paratransit Operations Maintenance Facility. It was sponsored by Congressman Mike Garcia, who represents Santa Clarita and the City of Lancaster where this project will be built. Senator Alex Padilla also sponsored the request on the

Senate side. He announced that in the most recent Appropriations Act that that was signed by President Biden, it was approved for \$3 million for the construction of the Access Antelope Valley Paratransit Operations and Maintenance Facility. He thanked the congressman and senator, as well as Jen Covino with Covino Smith and Simon, and Access staff who worked on the project. It was a big success, and it was assisted by the fact that the Board decided to purchase property in the Antelope Valley and also establish a facilities development and construction fund, which allowed them to go to congressional offices and state.

PUBLIC COMMENTS

Fernando Roldan made a public comment by stating that what was missing from the report is the lack of complaints on bad shared rides. It's something that needs to be discussed at the CAC and any committee meetings regarding bad shared ride routes. Something that needs to be addressed is also the newer vehicles. He hopes that they bring the new vehicles to the Abilities Expo, if not some other event so people can look at the newer vehicles.

OPERATIONS REPORT

Vicente Pena presented the statistics for the operations report. He stated the new, small Ram ProMaster was currently in production in Riverside. Two different orders are on the assembly and an order of 58 vehicles is almost complete with 49 delivered as of March 8th. The next order of 101 vehicles has started with 29 vehicles delivered so far. Once those two orders are complete, work will start on the next 48 more vans. The Access info line was updated with information on standing order rules and how they function as well as to how to submit compliments and complaints through the Access website. The phone number can be found in the riders guide and on the Access website. Lastly, Access held the community meeting on Zoom on February 24th. There were over 100 attendees, and a wide range of topics were discussed. The topics range from the Access Biannual Customer Satisfaction Survey, and Operations Monitoring Service, also known as OMC.

ZERO EMISSION BUS (ZEB) ROLLOUT PLAN

Eric Haack presented Access' ZEB Rollout Plan. The California Air Resources Board drafted innovative clean transit regulation guidance in 2019. A component of this was that transit agencies develop a Zero Emission Bus Rollout Plan. The elements required for the rollout plan are as follows. The plan seeks to know what Zero Emission vehicles the agency intends to purchase. Second, the plan then seeks to know what fueling or

charging infrastructure the agency will install for its vehicles. Examples include hydrogen fuel or battery charging technology. Third, the plan asks the agency to demonstrate that it will include deployment of these vehicles to historically disadvantaged communities. The plan then asks the agency to explain how staff will be trained in the new technology, focusing principally on driver and maintenance personnel. The funding sources may be secured that will help offset the cost of these new expenses and technologies. And finally, the plan seeks a discussion on the possible challenges or barriers an agency may face related to introducing Zero Emission Bus vehicles.

PUBLIC COMMENTS

Fernando Roldan made a public comment by stating that with the environmental issues they need a lot of clean vehicles. As far as the charging stations he asks them to partner with Metro to see if they could share some of their charging stations. Maybe they can also work something out with other bus companies around San Gabriel Transit, Antelope Valley, Santa Clarita, and the other regions.

EMERGENCY MANAGEMENT UPDATE

Alex Chrisman provided an update on emergency management. The Emergency Operations Center activated to duty officer status during the month of February providing storm intelligence and messaging to riders. The mass notification system was used to advise riders of peak storm conditions on February 4th and to recommend that riders consider rescheduling their travel. The agency website was also used to share this message along with the Where's My Ride app. Access hosted two tabletop exercises in recent months. The first was a simulated evacuation of a nursing home and a request for Access to assist with the relocation of the residents. Their eligibility contractor participated in another tabletop exercise that simulated the evacuation of the Eligibility Center due to a train derailment and a resulting chemical release. The Eastern region was also involved in this exercise since they provide transportation for the Eligibility Center. Both exercises were a great opportunity for staff to home their emergency management skills before an event happens. The Transportation Mutual Assistance Compact that Access helps administer now has 24 member agencies since Golden Empire Transit in Bakersfield, joined in July 2023. This marks the first agency from Kern County to join the group. TransMAC provides a framework for assistance and coordination among transportation agencies in the event of an emergency. This month, the TransMAC Steering Committee approved the second-ever update of the operating guide, which provides information about agency fleets and capabilities as well as detailed contact information.

PUBLIC COMMENTS

Fernando Roldan made a public comment by stating that he recommends these kinds of emergencies, including fire department, police departments of various locations. Some of the employees and clients are people in wheelchairs and walkers, and they should be prepared.

DRAFT VIDEO - HOW TO MAKE A RESERVATION

Matthew Avancena presented this video on how to make a reservation.

PUBLIC COMMENT

Fernando Roldan made a public comment by thanking Matthew Avancena for doing a good job on the video. He thinks it will help prevent wrong address mistakes for riders when they get picked up.

NEW BUSINESS RAISED SUBSEQUENT TO THE POSTING OF THE AGENDA

Vice Chair Amaya stated that the CalACT Conference is on April 15th through the 18th, for those that can attend the conference.

Chair Ishaq stated that the Abilities Expo is coming up soon.
