



NOTICE OF PUBLIC HEARING

PROPOSED NEW FARE SYSTEM FOR L.A. COUNTY'S ADA COMPLEMENTARY PARATRANSIT PROVIDER

NOTICE IS HEREBY GIVEN that Access Services (Access) will hold a public hearing to receive public input and comments on the proposed amendment to the Los Angeles County Coordinated Paratransit Plan related to paratransit fares. A quorum of the Board of Directors of Access may be present. However, no Board action will be taken. The location and time of the public hearing is as follows:

BACKGROUND

Access is proposing a new fare system because fares for ADA paratransit trips may not be more than twice the fare of a similar bus or rail trip. To calculate the Access fare for each trip, the cost of a comparable fixed-route trip would be doubled and then rounded down to the nearest fare level. The proposed fare levels are \$0, \$0.50, \$1, \$2, \$3, and \$4. Fares in Santa Clarita, Antelope Valley and fares for transfer trips will not be changing.

DOCUMENT AVAILABILITY

Materials related to the proposed change in fares can be found on Access' website (www.accessla.org) one week before the hearing. The public may also view and obtain all written information supporting the

public hearing at the agency's offices located at 3449 Santa Anita Avenue, Suite 200, El Monte, California one week before the hearing.

SUBMISSION OF WRITTEN COMMENTS

Access accepts both written and oral comments on the proposed amendment. Comments must be received by 5:00 p.m. on Monday, July 27, 2015.

PROCEDURAL MATTERS

At the hearing, there will be no sworn testimony or cross-examination of participants. However, Access and its staff may ask clarifying questions. Participants will be given an opportunity to summarize and supplement their written materials with oral presentations at the hearing if they so desire. To ensure a productive and efficient hearing in which all participants have an opportunity to participate, oral presentations may be time-limited. Participants may not cede their time to another.
